Discussion of the matter seemed to indicate an interest in doing a week-end perhaps, with more on this later. The Flabob Airport Show has been cancelled.

#### ZDDP IF IT IS GOOD ENOUGH FOR YOUR CLASSIC CAR THEN IT IS GOOD ENOUGH FOR YOUR TRACTOR By Bob Smith Zinc Dialkyldithiophosphate
